2023 will be a landmark year in the history of the trust — the Trust Deed was signed on 10th June

1983. With this in mind the trustees are starting to consider how best to celebrate this anniversary with gratitude for past success as well as plan for the future. With parish church finances under greater strain than ever, the call on trust funds is certain to be greater than ever; and the greater the trust's financial resources the more the trust can help parishes in their important work of maintenance and repair.

David's work for the trust has been outstanding but as I'm sure you know without an Hon Sec the trust cannot function. The Trust is an independent charity whose primary task is to give financial help in the form of grants and interest-free loans towards the cost of repair and improvement of churches and chapels of all denominations throughout Cambridgeshire. Its funds accrue mainly from the annual Ride, Drive and Stride and from membership subscriptions. Members receive twice-yearly newsletters and other information about the Trust's activities including an annual conference in the Spring and Sunday afternoon church tours in the summer. Secretary's Report

2020 has been a year unlike any in the Trust's history, or in living memory or a great deal longer. Our usual programme of events has been suspended, but that is a minor inconvenience compared with the upheaval and trauma suffered in the community as a whole, and compared with the impact of the pandemic on the churches in the county.

During the Spring lockdown many churches maintained their mission by means of on-line services as well as their members' contribution to community efforts to support vulnerable people, and many have resumed "live" services since this became permissible, despite the restrictions and the practical precautions required. However, a chasm has opened in many churches' finances because of the loss of vital income from social and fundraising events. We took the opportunity to highlight this situation by submitting evidence to the parliamentary Digital, Media and Culture and Sport Committee, who have been conducting an inquiry into the impact of the pandemic on the heritage sector. While churches are faith, not heritage organisations, like other owners of listed buildings they have a duty to the wider community for the care of the "heritage assets" in their tutelage. We shall wait and see how strongly our case weighs with Government in comparison with other more economically conspicuous and revenue-raising parts of the "heritage sector".

Meanwhile, the work of the Trust has by no means been "on hold". Despite the problems they encounter, churches have continued to approach us with applications for loans and/or grants. It is heartening that they have not lost sight of this element of their responsibility when faced with such daunting challenges. More of this on page 4.

Our ability to meet these requests depends on our income, a large part of which comes from the annual sponsored Ride and Stride. We had feared that this year this would be drastically reduced. Fewer churches than usual were open and fewer people rode and strode than usual, but those who did so rose magnificently to the challenge, and it looks as if we shall have received about £20,000, some £5,000 more than in 2019. As usual, 50% goes back to nominated churches.

In times like these we all have to hope for the best but be prepared for the worst. If circumstances permit, we shall go ahead with our Annual Conference at Wolfson College, Cambridge on Saturday 17th April 2021 "Timely Pointers to Heaven - Towers, Spires, Bells and Clocks". All but one of the speakers who were to appear in April 2020 have agreed to give their presentations then. However, we have to face the possibility that such gatherings will still not be permissible or that circumstances will for other reasons make a live conference unviable. We are therefore looking at the possibility of making the conference sessions available as a series of on-line lectures. Other organisations have been using this method with great success and have even expanded their audiences as a result. We realise that this would exclude those of you who do not have an Internet connection and we would have to find some other way of making the proceedings available. We shall have decide early in the New Year whether or not we can hold a live conference, and will let you know then what we propose.

Likewise we are contacting the churches that we had planned to visit on our tours in summer 2020, to see if they are willing to "pencil in" equivalent dates in 2021. Whether those visits materialise will obviously depend on the state of the pandemic, and not only whether such activities are by then permitted, but whether our members feel confident to travel and gather without risk and most importantly of all whether the churches concerned feel able to welcome us. The latest news about these tours and about the planned visit to Oxford in August will appear in our Spring Newsletter.

Canon Pritchard on page 1 seeks a volunteer to succeed me as Hon Secretary. In addition, many of you will have gathered that our long-serving Publicity Officer, Andrew Westwood-Bate, has had to resign because of serious health problems. The Trust is greatly indebted to Andrew for his unstinting and assiduous service over many years, and we need a volunteer to undertake this rôle which is even more vital in the digital age.

As we reported in the Spring, Jenny Lowles also did not feel able to carry on as Membership Secretary. We hope that a new Secretary will be able to include this work as part of his or her responsibilities. Meanwhile I have been doing my best to

keep membership business ticking over. From 1st January until further notice please send all communications about membership to smholgate@outlook.com or c/o 9 The Chase, Ely CB6 3DR.

Total membership currently stands at 176 individuals or pairs at the same address, and 142 churches. Our aim is to double our membership. Please see the message from our Vice-Chair on page 1 for how you can help achieve this.

Grants Secretary's Report

In all our buildings grants, we ask that the church architect or equally approved professional always supervises the work and issues a certificate of satisfactory completion. Amongst other things, it ensures that variations to the contract can be properly dealt with. At St John the Baptist, Somersham, the variations to (a standard) re-leading the south porch roof doubled the project cost; a number of rafters had to be replaced and repaired as well and having someone to manage this proved essential. The grant aided work is now almost finished.

Since the Spring Newsletter, we have awarded some of our largest grants to three "High Priority" cases. They were at All Saints Croydon, (structural movement particularly in the Chancel over the Downing vault), All Saints Morborne, (failing Collyweston slates on the nave and aisles) and St Mary's Whaddon where the church has been without permanent roof coverings to the nave and aisles since June 2019 when all the lead was stolen.

There have been other grants and loans as well to more "Maintenance" type work. These were at St Peter ad Vincula Coveney, (render, plaster and windows), Holy Trinity Great Paxton, (internal plaster), St Peter Wilburton (High Level repairs to stone and leadworks), All Saints Landbeach, (North Aisle and Chancel stone and render repairs) and St Andrew West Wratting, (Nave and Chancel stonework repair).

St Giles, Tydd St Giles, also benefitted from a loan; they had started work and found that they would also like to repoint and repair the south wall of their Lady Chapel in an ongoing contract.

"Fixtures and Fittings" also had a sympathetic ear at our meetings. St Peter Ely now has a new gas boiler to heat their church and although St Michael and All Angels Chettisham are still struggling to fund their organ repairs, a small grant offer has started their fundraising.
