

# Chairman's Report – New strategy launched

Following my note in the Spring Newsletter, the diocese of Ely launched its new strategy, 'People Fully Alive; towards Ely 2025' in the cathedral on 23rd September. http://www.elydiocese.org/who-we-are1/diocesan-strategy/ In his sermon, Bishop Stephen recognised that 'many parishes have developed their buildings in imaginative ways to enhance hospitality and multiple community use'.

The Trust has played its part and the list of recent grants and loans on page 4 shows how much we continue to help congregations (and not just those of the Church of England) to upgrade their buildings to secure both their worshipping congregations and to create new uses. The Bishop went on to say 'We definitely need the opportunity to re-imagine our buildings and to target support where there is the greatest need and the greatest opportunity. This is very important for our stewardship and mutual care.'

Trustees have decided to investigate the funding of another support officer with Historic England (the new grants

and advice agency that has emerged from the division of English Heritage). That person can provide parishes with the detailed advice and, most importantly, the confidence to work out how their church can serve their mission needs, without losing its essential historic character. It will not be easy, as so many people have a different idea of what 'their' church should look like (as Dr Williams explained to us so eloquently at last year's Garden Party). The successful regeneration of so many historic buildings demonstrates that it can be done - and done well.

I feel sure that CHCT will continue to help congregations financially and by supporting them to 're-imagine' their buildings, though that will depend both on getting more people involved in the running of the Trust and on raising enough funds to continue with our grants and loans. This is my last Chairman's Report and I am greatly indebted to my fellow Trustees and the officers of the Trust for their support and practical help in running the Trust over the last few years. I will remain a keen supporter from across the border but have no doubt that the Trust will continue to offer whole hearted support for the maintenance of the historic places of worship in Cambridgeshire.

### **CHCT Secretary's Report 2015**

The Trust's full Annual Report and Accounts can be found on our website, but if you would like a printed copy, please ask the Hon Secretary (contact details on the front page) for one.

Our main activities this year have been the Annual Conference and the four Church Tours. The former entitled 'The Search for Significance- writing about churches' was held at Wolfson College on May 9th, in part celebrating the publication of the two new Buildings of England volumes for the county. We were very fortunate to have both editors, Simon Bradley (Cambridgeshire) and Charles O'Brien (Huntingdonshire and Peterborough) explain their approaches to editing Pevsner's original text and showing us some of their discoveries. Dr Alexandra Buchanan, biographer of Professor Robert Willis, told us of his life in Cambridge and how his studies, particularly of English mediaeval cathedrals, remain the foundation of our understanding of their architectural development. Dr Roger Bowdler of Historic England explained how decisions are made to list, schedule or designate today and how the criteria have evolved since the losses of the Second World War prompted the start of listing.

The day was well attended and even made a small profit. It also included a session in which subscribing members received a report on the preceding year's grant giving with an opportunity to comment and ask questions.

The 2015 Church tours reached the far corners of the county, with two crossing the borders. Our thanks to the congregations for hosting us and especially to those who supplied tea as a welcome finish to the afternoon.

### Membership Secretary's Report

The Trust's total membership as at 30 June 2015 stood at 278 consisting of 187 individual members (including 32 joint members at the same address) and 91 corporate or church members. This is a slight drop in numbers compared to 2013-4.

We have welcomed 14 individuals, 12 churches and a Buildings Preservation Trust as new members since 1 July 2014. There have been 8 resignations and 9 members were removed as they were either in arrears or were not paying the correct subscription.

# **Grants Secretary's Report**

During the year we offered £41,000 in grants to 21 churches as well as £243,000 in loans to 17 churches, all from our own resources. This huge increase on 2014-15 makes up for the previous year of low offers and was partly achieved by releasing some capital for grants. Lower rates of interest and decreased income from the Ride, Drive and Stride mean that we will not be able to offer as much in 2015-16. Two offers have been made for the conservation of monuments, eleven for fabric repair projects, two for access improvements and nine for toilet/servery/heating schemes to make churches more useable.
