

# Give someone a year's membership of the Cambridgeshire Historic Churches Trust and help the Trust preserve our county's rich inheritance.

Cambridgeshire has more than 300 churches and chapels of historic and architectural interest. They span over a thousand years from the Saxon period at Great Paxton to the High Victorian at Waresley and the 20th century at the Good Shepherd, Arbury.

The care of places of worship is the responsibility of the local church community who carry the burden of continuous maintenance and the raising of funds for repair. The Trust, founded in 1983, helps churches of all denominations with grants, loans and advice. It offers funding towards improvements which enable the building to be more widely used in the 21st century, eg projects that provide toilets and serveries, better heating and modern wiring.

The Trust also awards small grants towards the repair and conservation of memorials and monuments, including those in churchyards. Since its foundation, the Trust has offered over £2 million in interest free loans and over £500,000 in grants for works of repair and improvement.

Priority is given to making loans (currently up to a maximum of £20,000) as these help congregations embark on a project with the confidence that they can manage the cash flow – and once work starts, donations often increase.

Alongside this main business, the Trust organises events which encourage everyone to enjoy and to understand the art and architecture of the county's churches and chapels. There is an annual conference in the Spring, for which members pay a reduced fee, and there are church tours in the summer months, led by distinguished local experts in architecture and iconography, for which there is no charge. Members also receive newsletters twice each year.
